NOTE: The first line of the review shows the current price for the futures selected and then uses the high percentage times this beginning price to arrive at the price the futures would move up to based on the historical high price percentage of the starting price. Then we take the low percentage times the beginning price to arrive at the price the current futures might move down to and we use the historical ending percentage to arrive at what price this years futures might end at.
